Lemon Festival 2015 - This summer street fair was held on Sunday, August 2, 2015 from 10 a.m. to 5 p.m. and annually celebrates Chula Vista's heritage as the lemon capital of the world. The event attracted 30,000 people to Chula Vista's Third Avenue business district with live entertainment on two stages, a craft beer garden, as well as craft, commercial and food vendor booths. The event was held within the Third Avenue business district from E Street to G Street. Cost to host the event was \$18,990.

Avenue Amps & Ales - This springtime craft beer and music festival was held on Saturday May 14, 2016 from Noon to 6 p.m. celebrating the arrival of this new industry to the Third Avenue Village. The event entertainment included live bands, artisans, commercial, and food vendors. Cost to host the event was \$16,387
